### RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

PLEASE READ CAREFULLY. THIS AGREEMENT AFFECTS YOUR LEGAL RIGHTS. BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL CLAIMS AND REMEDIES.

In consideration for being permitted to participate in the Tour, Trekking, Hiking, Climbing, International Travel, and Related Activities (hereinafter collectively referred to as the "Activities") organized by Imperial Expedition LLC (hereinafter referred to as the "Company"), I, \_\_\_\_\_, hereby acknowledge and agree to the following terms and conditions:

- **Assumption of Risks:** I acknowledge that the Activities involve inherent risks, hazards, and dangers that cannot be eliminated, including but not limited to risks associated with outdoor activities, physical exertion, adverse weather conditions, transportation, equipment failure, remote locations, encounters with wildlife, and the potential for injury, illness, or death. I understand that the Company cannot guarantee my safety or eliminate these risks.
- **Release and Waiver:** In consideration for being permitted to participate in the Activities, I, on behalf of myself, my heirs, executors, administrators, and assigns, hereby release, discharge, and hold harmless the Company, its owners, directors, officers, employees, agents, contractors, guides, and representatives (collectively referred to as the "Released Parties"), from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or death, whether caused by the negligence of the Released Parties or otherwise, arising from or in connection with my participation in the Activities.
- **Waiver of Claims:** I waive any and all claims, known or unknown, that I may have against the Released Parties arising out of or related to the Activities. This includes claims for personal injury, property damage, wrongful death, or any other loss, and includes claims based on negligence, strict liability, breach of contract, or any other legal theory.
- **Indemnification:** I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, actions, suits, demands, judgments, costs, and expenses, including reasonable attorney's fees, arising out of or in connection with my participation in the Activities.
- **Governing Law and Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of the state or jurisdiction in which the Company is located. Any legal action or proceeding arising out of or related to this Agreement shall be brought exclusively in the state or federal courts located within that jurisdiction.
- **Severability:** If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.
- **Entire Agreement:** This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior discussions, negotiations, and agreements, whether oral or written.
